- **Draft Merrimack Valley 2020 Regional Transportation Plan (RTP)**

The RTP examines the existing multimodal transportation network in the region, identifies problems that will require improvement, and outlines possible courses of action to facilitate these improvements. The RTP also identifies transportation projects and estimates available funding resources through the year 2040.
