## **Remote Participation Requirements and Procedures**

Per 940 CMR 29.10(7), Mr. Barry contacted Chair Eugenie (Janie) Moffitt in sufficient time prior to the meeting with the request to participate in the meeting remotely. Pursuant to 940 CMR 29.10(5), Chair Moffitt so notified the members of his request, gained their approval, and called the meeting to order at 7:00p.m. in the Second Floor Conference Room, and initiated roll call. Ms. Anderson pointed out that the Board of Selectmen voted to recommend approval of Article 4 in the amount of \$187,494,538, according to the Town Clerk's tracking sheet. This amount is \$15,965 more than the net total of the Article 4 FY2020 operating budget. Ms. Walsh will follow up with the Board of Selectmen.
