#### Call to Order

Date: June 23, 2021

#### Roll Call

Chair Moffitt called the meeting to order at 7:00PM and initiated roll call. Present were Chairperson Eugenie Moffitt-Y, Andrew Betts-Y, Mary Ellen Logee-Y, Paul Monticciolo-Y, Kevin O'Handley-Y, Linn Anderson-Y, Spiro Christopulos-Y, John Barry-Y and Paul Russo-Y. Also in attendance was Donna Walsh, Finance Director. The meeting was videotaped and cablecast.

#### FY21 Year End Transfers - Ms. Walsh

Ms. Walsh explained that under MGL Chapter 44 Section 33B, along with the approval of the Select Board and Finance Committee, transfers from the FY21 operating budget can be made. Ms. Walsh reviewed the attached list of accounts and the reasons for the transfers. If there is need for additional transfers, she will come back to the Finance Committee for approval before closing of the books on July 15<sup>th</sup>. Discussion ensued with regard to the impact of COVID on the budget and reimbursement of some charges by the CARES fund.

Upon motion duly made by Mr. Barry and seconded by Mr. Russo, it was unanimously voted to approve the FY21 operating budget transfers as presented. Chairperson Eugenie Moffitt, Andrew Betts, Mary Ellen Logee, Paul Monticciolo, Kevin O'Handley, Linn Anderson, Spiro Christopulos, John Barry-Y and Paul Russo-Y. Motion passed 9-0.

### **Liaison Updates**

Ms. Moffitt noted that she was pleased to see that the Pension Obligation Bond passed both at Town Meeting and at the ballot. Success was attributed to the fifty-three educational public forums containing a significant level of detail held prior to Town Meeting by the Town Manager.

Mr. Monticciolo made the request for the Town Manager to record a general public educational video on a primer "municipal government 101" available on the website. Discussion ensued on the advisability of this initiative for the benefit of a well-informed educated public on the workings of municipal town government.

### Pension Obligation Bond Timeline - Town Manager

The Town Manager reported that he will be announcing appointments to the Investment Committee on July 19<sup>th</sup>. The Department of Revenue will review the request to go forward with the issuance of a pension obligation bond, and Hilltop Securities will begin the process that will be finalized in late September, early October. Discussion ensued on the timing, amount and costs of the borrowing. Also discussed was the advisory role of the Investment Committee to the Retirement Board.

# **Letter to the Finance Committee**

Ms. Moffitt referenced the letter from a citizen received by the committee (see attached.) Discussion ensued. It was agreed that general education to the public on the constraints of the town in consideration of pre-existing municipal laws will be helpful.

## <u>Meetings – Hybrid Format</u>

Mr. Lawlor noted that Andover TV is working on continuing a remote and in-person meeting format commencing in the fall. Discussion ensued on the logistics and quorum requirements of these meetings.
