Ch. 304 Annual Liquor License Establishment Fire & Life Safety Inspections \$50.00 per visit

Fire Watch Details are calculated by the current detail rate. All details are 4-hour minimum.

Records Search, Ch. 21-E Site Assessment (950 CMR 32.06) \$25.00
